

Subject:- Revision of emoluments of University Grants Commission Post Doctoral Fellowship for SC/ST Candidates-regarding.

Sir/Madam,

In reference to this office circular of even number dated 22.08.2012 the University Grants Commission has made the following revision/amendments under the scheme of Post Doctoral Fellowship for SC/ST Candidates w.e.f. 01.04.2009, details are given as under:-

S.No	Item	New Revised Rate of Fellowship# (w.e.f. 01.04.2009)	Tenure of Award
1	Fellowship	@ Rs.25,000/- p.m. for first 2 years & Rs.30,000/- p.m. for rest of the three years.	Five Years
2	Contingency	@ Rs.50,000/- p.a. (w.e.f. 27.04.2012) for the remaining tenure on pro-rata basis	
3	Departmental Assistance	Not admissible, w.e.f. 27.04.2012. Prior to 27.04.2012, it will be admissible on pro-rata basis @ 10% of the Post Doctoral Fellowship to the host Institution	
4	Escorts/Reader/ Assistance	@ Rs.2,000/- p.m. (fixed) in cases of physically disabled & blind Candidate	
5	HRA	As per categorization of the cities by the Government of India.	

1. The new revised rate of fellowship and other emoluments are also applicable to the candidates who have been selected since the year 2006-07 onwards. However, if the fellowship is already availed for two years and its term is over, the extension thereof is not permissible. Also, it cannot be re-started for the remaining period.
2. The Universities/Colleges/Institutions are requested to make the admissible payment of the arrears to the awardees out of the unspent balances lying with them from the grant sanctioned under the scheme of Post Doctoral Fellowship for SC/ST Candidates. In case, the balance is not available, it is requested to make the payments to the eligible awardees as per above guidelines and claims thereof may be sent to this office for the reimbursement of the admissible amount
