Dear Sirs,

As you are aware that National University of Educational Planning and Administration (NUEPA), New Delhi has been entrusted with the responsibility of conducting All India survey of Higher Education for preparation of a reliable and comprehensive database. Directorate of College Education, Rajasthan, has been nominated by the state government as a State Coordinating Agency (SCA) for the same.

A portal has been developed by NIC (URL: <http://aishe.gov.in>) on which all the survey related information is available. Three Data Capture Formats (DCFs) have been designed for the purpose of data collection. These are DCF-I, DCF-II, and DCF- III which can be downloaded from the portal, filled up and uploaded on the same portal.

The universities are required to fill up the complete data in DCF-I. The affiliated colleges have to fill up their complete data and upload in DCF-II. The institutions which are not affiliated to any university but which are recognized by some council or state Government are called as "Stand Alone Institutions (SAIs)". These SAIs are also required to fill up their complete data and upload in DCF-III.

It is also important to note that DCF-II cannot be uploaded by affiliated colleges until their affiliating university does not upload the DCF-I on the portal. So affiliating universities has to play leading role in uploading the DCF-I in the state.

Kindly note that DCF requires the information about institutions, teachers and students will be recorded on the basis of their actual numbers as on 30th September 2010 for the academic year 2010-11. Information in respect of examination results will be collected for the students passed out/ awarded degree during academic year 2010-11 and financial information will be recorded for the financial year 2010-11 i.e. 1st April 2010 to 31st March, 2011.

You are requested to go through the details and content on the portal and upload the DCF-I and DCF-III as applicable to your institution at your earliest and intimate us immediately.
