Vide above referred letters, all Heads of Departments and Budget Controlling Officers were directed to ensure that the Expenditure Reports and data of PD Accounts available in IFMS are complete, updated and accurate in all respects by checking the reports available on IFMS and making necessary corrections through Treasuries by October 20, 2011 under intimation to Finance Department.

As you know, completion of this task is of utmost importance for effective budget distribution and control module under IFMS but the reports available in IFMS indicate that this task has not yet been completed by many of the departments, which is a matter of concern.

It is, therefore, again requested to please look into the matter personally and ensure that this task is completed positively by November 30, 2011 by checking various reports (Expenditure, Budget Distribution and Budget Availability) in IFMS with the physical record available in the Department and intimating necessary changes in regard to misclassification to the respective Treasury for reconciliation. It would be pertinent to mention here that after November 30, 2011 Treasuries will not be able to accept any kind of bills of the offices which fail to complete the task of reconciliation of these figures.
