

## For Issuing Advisory to University

In context of University of Rajasthan's adoption of new affiliation rules for private colleges based on UGC (Affiliation of Colleges by University Regulation, 2009) for academic session 2011-12, a series of representations have been received by the State Government wherein it has been stated that the new norms required for land as well as endowment fund are excessive and impinge on the economic viability of the institutions concerned. It has further been stated that if the UGC norms are insisted upon, many existing colleges would close down and it is unlikely that new colleges would be cpened up in the coming vears.

The gross enrollment in Colleges in the State of Rajasthan is below the National average. Hence, it needs to be ensured that there is no set back in the efforts to expand the outreach of Higher Education Institutions to cover as large a number of students as is possible. Accordingly, the State Government has decided to set up a committee of experts that would objectively examine the norms set by UGC in respect of minimum land requirement as well as the endowment fund, its viability as well as impact on Higher Educational institutions and opportunities. Therefore, it would be appropriate that till the regent of the committee is received, all States Universities in Rajasthan may keep the norms in respect of land and endowment fund - as contained in the UGC affiliation of colleges by University Regulation, 2009 - in abeyance.

However, with a view to ensure a balance between economic viability on one hand and maintaining educational standards on the other, the following minimum norms may be considered in the interim period:
