

Note -

- The Principal shall constitute a committee for proper and effective utilization of the budget sanctioned under the scheme of Centres for Excellence. The committee shall decide items and services to be procured (with detailed specifications).
- The purpose of issuing these guidelines is to ensure availability of certain basic facilities in all Model Colleges hence the colleges are directed not to skip any item of the table if the same is not available in the college. It shall be assumed that college has arranged an item from other resources if it has been skipped.
- The amount against each item/head is suggestive. Hence it is not necessary to spend full amount on the said item. Moreover, the college may pool money from other sources if the amount required for a specific item exceeds above mentioned limit. Savings of each item may be transferred for remaining items.
- Requests for re-appropriation may be entertained in rare cases on the basis of justification provided.
- Execution may be made simultaneously for items mentioned in the above list. The college administration need not wait for completion of one activity before commencing work on next item in the list.
- The amounts have been included in the allocation just to ensure that a particular activity gets proper attention of the institution. The allocated amount in any way is not indicative of importance of an activity nor does it suggest that activities/items not included here are not necessary for a model college.
- The annual lecture should not be organized for a select audience such as participants of a Conference/Seminar organized by the college or activity of a department. Due diligence should be applied in selection of eminent personality and topic of the lecture.
- The colleges are expected to strictly follow GF&R and other rules/notifications/orders issued by the State government.
- All colleges are expected to send a quarterly progress report and a final utilization report (by 15th April 2013) to Jt. Director (Planning and Coordination), Directorate of College Education (the final utilization report should contain details of activities carried out, expenditure made on different items, title of lecture organized etc. and other support materials).
